3. Included in Price Plan

3.1 Data

- (a) Each Vodafone Mobile Broadband connection will have the data allowance set out in the Price Plan Ladder that can be used without an additional charge.
- (b) All other data usage on the Vodafone Mobile Broadband plans shall be charged at the out of bundle rates set out in this Price Plan Guide.

3.2 Roaming and Data:

(a) Inclusive Roaming Destination

- (i) The Republic of Ireland is an inclusive roaming destination for all Vodafone Mobile Broadband Customers.

(b) Roaming in Europe Zone 1

- (i) From 26 January 2022, Customers using Vodafone Mobile Broadband Tariffs that do not offer inclusive roaming in Europe Zone 1 will be subject to a £2.00 daily fee ('Daily Fee') when roaming.
- (ii) The Daily Fee when roaming in our Europe Zone 1 will be triggered when a customer generates any voice, sms or data use from their connection.
- (iii) The Daily Fee is charged on a per connection basis and will allow customers to access their domestic tariff allowance when roaming in Europe Zone 1.
- (iv) Customers may also opt into one of our Europe roaming passes that will grant access to their domestic tariff allowance while in Europe Zone 1. These passes can be added before you travel or while you are travelling by contacting Vodafone and will only be billed for when activated by any generated voice, sms or data use while in Europe Zone 1. Where Customer opts into purchasing a roaming pass, the £2.00 daily fee will not apply.

(A) 8 Day Europe Roaming Pass = £8 (£1 per day)

(B) 15 Day Europe Roaming Pass = £15 (£1 per day)

- (v) The Daily Fee will apply when usage is generated as above whether the customer is opted in or out of Business Traveller.
- (vi) Outside of Europe Zone 1, roaming rates, where applicable, are set out below.
- (c) **Business Traveller:**
 - (i) Customer will be automatically opted in to Business Traveller within Vodafone Mobile Broadband
(take UK minutes, texts and data abroad for £2.50 a day per Connection in Vodafone's Europe Zone 2 and £5.00 a day per Connection in Vodafone's World Zone). Customer may opt out of Business Traveller at any time, and may choose not to opt in if Customer prefers, however some roaming charges may still apply.
 - (ii) By opting into either of the Business Traveller options set out above, Customer will automatically opt out of the 50 euro monthly spend limit for data in Business Traveller countries, together with associated notifications, because Customer will be using its UK data allowance.
 - (iii) Customer can opt out of Business Traveller with Vodafone Mobile Broadband at any time and will revert to Standard List Price roaming rates and the 50 euro monthly spend data cap.
 - (iv) The Business Traveller Price Plan Guide applies to Customer's use of Business Traveller (please see www.vodafone.co.uk/businesstraveller).

4. Opt in Option for Using Data in the UK

A 2GB 5G data bundle can be added on Data 2 plan and SF Data 2 plan. The data bundles can be used while roaming if opted in Business Traveller, this will only apply to countries/destinations in Business Traveller (refer to www.vodafone.co.uk/terms for more details).

6. Travelling and Using Devices Abroad

6.1 Business Traveller:

The following Charges apply for Business Traveller (unless Customer opts out – other roaming charges will still apply including Daily Fee and standard roaming rates)). The Charges apply per Roaming Zone.

7. Data and Text Outside the UK

8. Opt in Options - Roaming Data Caps

When Roaming Data Caps are added, they will override the standard roaming cap of £39.33 (50 euro spend cap) and give a new cap in Europe Zone 2 and Rest of World Zones. Notification sent at 80% of usage, then capped at 100% of usage. When used with Business Traveller will not take into account Business Traveller countries.

9. Inclusive European Roaming Fair Usage Policy

9.1 Inclusive European Roaming services are intended for use during periodic travel and not for customers roaming across foreign networks on a semi-permanent or permanent basis.

9.2 If Customer or Customer's Users use its mobile in the inclusive European Roaming Zone for more than 50% of the time in any 4 month rolling period, they will receive a text requesting more moderate use of Vodafone's roaming services.

9.3 If Customer or Customer's Users usage in the inclusive European Roaming Zones continues to exceed 50% as described above, over the 2 week period following the first notification, Customer may be charged for further use or Vodafone may bar Customer from using Vodafone's roaming services. Customer will be notified before Vodafone applies the bar.

10. General

10.1 Any data allowance or usage increment relates to use of all or part of the specified amount. Charges are correct at time of print.

10.2 The Corporate Mobile Broadband SIM Only Price Plans and Smart Funding Mobile Broadband Price Plan are 4G and 5G enabled. Speeds may vary subject to network coverage, capacity, and the mobile broadband device used for connection.
